### Recap & Next Steps

**Recap:**

- Mireya Eavey with CareerEdge welcomed the group and invited everyone to introduce themselves. She then turned it over to Casey Welch at USFSM who provided background on the public policy agenda of the workforce council.
- Holly Bullard with the Florida Policy Institute shared that lawmakers have expanded eligibility for the Florida Healthy Kids Program which is part of the Affordable Care Act. She also shared that \$115 million from the affordable housing trust fund has been moved to support counties impacted by Hurricane Michael. This left \$85 million in the affordable housing trust fund for the entire state. Both funding allocations have been approved by state lawmakers and are waiting for action by the Governor (sign or line item veto).

- Elizabeth Cordes with the Bradenton EDC shared that everyone should encourage businesses to register with <https://floridadisaster.biz/> as it is difficult for the federal government to determine revenue loss for Florida businesses.
- Mireya Eavey explained CNA testing delays have been reduced because the Red Cross and STC are now pre-registering CNA students for the exam. Representatives Good and Gregory are working on amended language that will allow licensed nursing schools to perform onsite CNA testing. The language has been provided to them so that their staff can work on the statute revision over the summer, prior to session.
- Casey Welch said Voluntary Pre-Kindergarten will remain a topic, as the formula funding is disproportionate. Ashley Brown with WRC said volunteers are still needed for the summer reading program. Casey Welch reminded the group that legislative session starts January 14, 2020 and committee meetings for this fall are scheduled.
- HB 7071 was the 2019 Legislative Session workforce bill; with 65 pages it covered many different topics. A few the bill included are:
  - Creation of a College and Career Decision Day – signing day at high schools
  - Career and Education planning for 6,7,8 graders to develop a plan for attending college or technical school, which can include apprenticeships
  - Credits toward high school diploma for students working in the trades or in technical school
  - Increasing the talent pipeline for 60% of older adults by 2030
  - Florida Career pathways grant to provide grants to high school students
  - Important to note that the above programs do not have funding allocations
- Casey asked the group to provide topics for the upcoming workforce summit. Mireya and Casey are finalizing the agenda and speakers, with an official invitation to go out this week. John Annis with the Baranick Foundation suggested reaching out to the representatives and start conversations with each around their policy interests. John said conversations with lawmakers should be high level while the summit attendees can work out the details.
